The IT sector showed resilience, particularly after the election, with companies like TCS and Infosys demonstrating positive performance in metrics like Jensen Alpha and Treynor Ratio. The Banking sector exhibited mixed results, with ICICI Bank and Axis Bank performing relatively better during and after the election compared to others. However, the FMCG sector, especially Nestle and Hindustan Unilever, struggled to recover post-election, as indicated by persistently negative Jensen Alpha values. The correlation analysis between the sectors and NIFTY 50 revealed varying degrees of linkage before, during, and after the election, with stronger correlations seen during the election period, suggesting heightened market sensitivity to political developments. Finally, through the event study methodology, the unit roottest and GARCH model confirmed significant volatility around the election, validating the event's impact on stock prices. Overall, the study emphasizes the varying sectoral performances and highlights the importance of political events in shaping market behaviour.

(Sanjib Biswas, May 2023)Effect of COVID-19 on Stock Price: A Time Series-Based Analysis of FMCG and Consumer Durables Sector in India. May 2023

The present study attempts to analyze the immediate short run impact of the COVID-19 crisis on ISM focusing two sectors such as Fast-Moving Consumer Goods (FMCG) and Consumer Durables (CD) listed in BSE, India. Since, the products of these two sectors are of common use by the household, it is interesting to unveil the impact of COVID-19 on the stock prices of the constituent companies. The study period is from April 01, 2013 to March 31, 2021. We consider top 25 FMCG and 05 CD stocks based on their aggregated market capitalization (for the period FY 2013-2014 to FY 2020–2021). Monthly closing stock prices of were collected from the BSE database. The underlying objective is to uncover the nature of impact of COVID-19 on the stock prices of these companies. A time series analysis is carried out to discern the effect of the outbreak of COVID-19 on the closing stock price movements of the companies under study. We use autoregressive integrated moving average (ARIMA) model to predict the monthly closing prices for the period April 2020–March 2021 and calculate the deviation for all the stocks. It is seen that the companies got hit by COVID-19. The result contradicts the fact the companies which have multiple products and better reach in the market could stand. - 3. To research which factor mostly impact on the Gopal Snacks Limited Stock prices.




Figure 1: What is your gender?




Figure 2: What is your age?




Figure 3: What is your education qualification




Figure 4: What is youer income level?




Figure 5: Which field you are working




Figure 6: Are you gamillar with investment strategies or financial planning?




Figure 7: Are you aware of IPO (Initial Public offering)? (IPO is when company raise funds for first for first time throught market)




Figure 8: How long have you been involved in stock market?




Figure 9: From where do you get information about the stock market?




Figure 10: What are brand that can give good competition to Gopal Snacks Limited's Share?
